# Zero Emission Vehicle Infrastructure Program – Delivery Organizations

Zero Emission Vehicle Infrastructure Program (ZEVIP) for delivery organizations (also known as, Initial Recipients) further distribute ZEVIP funds to "Ultimate Recipients" to install electric vehicle (EV) charging infrastructure in public places, on-street, in multi-unit residential buildings, at workplaces, or for on-road vehicle fleets. The third-party
